Statistics of International Trade in Services: Challenges and Good Practices Workshop for the South East Asian (SEA) countries 30 November – 3 December 2010, Hanoi, Vietnam

I. Organization, purpose, objective and participants of the Workshop

The Workshop on "Statistics of International Trade in Services: Challenges and Good Practices" for the South East Asian countries was organized by the United Nations Statistics Division (UNSD) in close cooperation with General Statistical Office of Vietnam. The workshop is organized within the framework of the UN/DESA Development Account project for the strengthening of the statistical capacity of countries in South East Asia. The workshop took place in Hanoi, Vietnam between 30 November and 3 December 2010.

The workshop aimed to provide training to representatives of national statistical offices, central banks of Cambodia, Laos, Myanmar, Timor-Leste and Vietnam on the methodology of trade in services statistics and on current country-practices in compilation of trade in specific services sectors. The training focused on both the interpretation of conceptual issues and options for the implementation of the international recommendations, taking account of country specific circumstances and facilitating the establishment of a network of statisticians among these South East Asian countries. The workshop reviewed particularly the travel item and tourism statistics.

The workshop was attended by 30 participants from the SEA countries and international organizations. Representatives of the national statistical offices and the central banks of the SEA countries participated at the workshop, namely Cambodia, Myanmar, Lao, Vietnam and Timor Leste. The following international and supranational organizations sent representatives as resource persons to the workshop: the Statistical Office of the European Communities (Eurostat), the United Nations Statistics Division (UNSD) and the World Trade Organization (WTO).

II. Summary

Tuesday, 30 November

Opening session

Ms. Tran Thi Hang on behalf of Dr. Do Thuc, Acting President of the General Statistical Office of Vietnam and Mr. Ronald Jansen, Chief of the Trade Statistics Branch on behalf of Paul Cheung, Director of UNSD addressed the participants. Morning sessions Overview of the new recommendations on Statistics of International Trade in Services" and "Overview of the SITS data availability and institutional arrangements in South East Asia". The "Resident – Non-resident trade in services" session consisted of the following presentations: "Overview of the Balance of Payment and Investment Position Manual (BPM6)" and "Malaysia Balance of Payment" –

Afternoon sessions

The Extended Balance of Payment Services (EBOPS) classification section included the following presentations: "BOP/EBOPS/CPC", "Definitions in SNA 2008", "International Trade in Services Statistics of Vietnam".

Wednesday, 1 December

Morning sessions

The Data collection of resident-non-resident trade in services statistics section included the following presentations: "International Transaction Reporting System (IRTS) – overview", "Enterprise surveys", "ITS Census 2009 in Vietnam", "ASEAN requirements for SITS", "Cambodia experience in SITS". The following topics were discussed in parallel groups: Cooperation of the national statistical office and the central bank in collecting SITS data, ITRS, enterprise survey, household survey and other data sources.

Afternoon sessions:

The Foreign Affiliates Statistics, FDI and Multi-National Enterprise statistics session contained the following presentations: "Foreign Affiliate Statistics (FATS): concepts, legal framework and EU data", "Foreign Direct Investment (FDI) statistics" and short presentations on FDI from Vietnam and Cambodia.

Thursday, 3 December

The Trade in services statistics by modes of supply session included the following presentations: "Measuring trade in services by GATS modes of supply", "Development of Foreign Affiliates Statistics (FATS) – Mode 3 in Malaysia". The metadata and quality of trade in services data session included the following presentations: "Data quality and metadata" and short presentations of the participating countries. The parallel discussion groups were focusing on the following issues: data quality assessment, the importance of providing metadata, FATS data collection and data quality. The travel and tourism statistics section included the following presentations: "Overview of the International Recommendations for Tourism Statistics 2008 (IRTS 2008)", "Recommendations of the Workshop on "Developing National System of Tourism statistics: Challenges and Good Practices" (Vientiane, Lao DPR, 16-19 June 2009)", "Vietnam experience in tourism statistics".

Friday, 4 December

The recommendations adopted by the participants were gathered in nine groups as it follows.

The participants at this workshop:

I. General

- 1. Concluded that the event provided an excellent opportunity for countries to review the status of SITS compilation in the region, to elaborate challenges, to share their experiences and good practices as well as to obtain basic knowledge and further guidelines on BPM6 and MSITS 2010; the participants expressed their gratitude especially to the General Statistical Office of Viet Nam for being an excellent host and to the workshop organizers;
- 2. Recognized the efforts made by countries to the application of the MSITS2002 / BPM5 and concluded that countries face many challenges to comply with the recommendations of the revised manual, MSITS 2010 along with the BPM6, and that they will keep producing for the time being in MSITS2002 / BPM5 while preparing initial steps in the direction of implementation of the new international standards; expressed particular concern regarding the feasibility of compilation of the new BPM6 item of manufacturing services on physical inputs owned by others;
- 3. Expressed appreciation to the experts of WTO, Eurostat and the Department of Statistics Malaysia for sharing their knowledge and experience on SITS and FATS;
- II. Statistics on resident/non-resident services trade in services

Strengthening legal basis

4. Noted the importance of the legal basis for the SITS compilation; and encouraged a closer cooperation among the relevant national agencies;

Methodological issues

5. Agreed that the EBOPS categories are used for data collection and dissemination;

- III. Foreign Affiliates Statistics (FATS)
 - 6. Agreed that FATS is of a high policy and analytical value and encouraged countries to continue or initiate the feasibility study of compiling such statistics; priority should be given to inward FATS as recommended in MSITS 2010 and countries are encouraged to begin dissemination of inward FATS in the near future;
- IV. Quality, metadata and dissemination
 - 7. Agreed that the quality of SITS remains a challenge and strengthening quality assurance programmes is required in countries;
 - 8. Stressed the importance of publishing appropriate metadata to enhance data quality;
 - 9. Concluded that (EBOPS and FATS) data reconciliation between interested partner countries is strongly encouraged;

V. SITS by mode of supply

- 10. Recognized the value of SITS by mode of supply and agreed that estimation of such statistics is encouraged using the simplified approach based on the availability of SITS and FATS;
- VI. *Capacity building*
 - 11. Realized the importance of further regional and national training programmes on (specific aspects of) SITS and FATS;
 - 12. Urged TFSITS to soon complete the compilation guidance for the MSITS2010 manual, including good country practices, and to assist countries in the MSITS2010 implementation;
- VII. What's next?
 - 13. Welcomed UNSD's intention to place all workshop documents on the dedicated website of the workshop for reference and to develop a knowledge base on SITS and FATS.
 - 14. Encouraged countries to cooperate with UNSD in providing the most recent SITS data and metadata needed to update the UN Service Trade database;
 - 15. Encouraged countries to develop action plans to implement the recommendations contained in the revised MSITS2010 on SITS and FATS, and inform UNSD accordingly;
