KENYA AND EGRIS

- Kenya has been implementing some of the recommendations from IRRIS and IRIS
- One strategy that has worked for Kenya
 - intersectional collaboration among stakeholders within the NSS

Objectives of Intersectional Approaches:

- Respond to policies and data needs.
- Build on the human rights-based data principles of:
 - participation, data disaggregation,
 - ✓ self-identification, transparency,
 - Privacy and accountability.

How Kenya has Implemented the Approach

- ✓ Technical Working Committees
- ✓ Action Plan for the Inclusive Data Charter
- ✓ National Strategy for Development of Statistics.

DATA COLLECTION

1. Adminstrative Data

- Kenya has been reporting on Refugees and Asylum Seekers in the annual reports
 - Economic Survey
 - ✓ Statistical Abstract
- Source: Refugee Affairs and Secretariat
- Variables: Number of refugees and asylum seekers by:
 - ✓ Sex, Age
 - Location and Country of origin

2. Census:

- Kenya conducted the last population and housing census in 2019
- Questions on ethnicity/nationality and reasons for migration were asked during 2019 KPH Census. These targeted indicators on the refugees, stateless, IDPs among others
- Census results are lower than data from administrative source

COLLABORATION WITH HUMAN RIGHTS COMMISSION

- ❖ At the Bureau, Statistics on Human Rights is hosted within the Governance Peace and Security Statistics Section
- * KHCHR and KNBS signed a 5- year MOU in 2017 to ensure collaboration on human rights issues
- ❖ Both Institutions have assisted each other to understand the fields of human rights and statistics

ACHIEVEMENTS FROM THE MOU

- ❖ Inclusion of the following questions/options in the 2019 census questionnaire:
 - ✓ Intersex, Stateless,
 - ✓ IDPs, Refugees and Asylum Seekers,
 - ✓ WG_SS of Questions on Disability, Persons with Albinism and
 - ✓ Indigenous Ethnic Groups
- Inclusion of the Commission in the Governance, Peace and Security Statistics and Disability Statistics TWCs
- Capacity Building workshop for both institutions
- Collaboration during Cognitive test and Pilot survey of Tier III of SDG 16 Indicators organized by UNDP, OHCHR and UNODC

WAY FORWARD

- * KNBS to include KNCHR Kenya Strategy for Development of Statistics Framework and other TWCs
- * Active information sharing: between and within the National and County level offices of both institutions
- Continuous capacity building and proposal to have MOU Implementation committees
- Joint resource mobilization for more surveys, publications and interventions and
- * KNCHR to provide networks and linkages with CSOs
