## **The Working Group**

The Working Group on Geographical Names as Cultural Heritage was established to address Resolution 1 of the Eight Conference (Berlin, 2002) as Working Group on the Promotion of Indigenous and Minority Group Place Names, with the aim to oversee the activities related to the promotion of indigenous and minority geographical names as means of cultural retention/ revitalization. The name of the WG was changed at a side meeting at the 27<sup>th</sup> Session in New York 2012.

The aim for the Working Group is to oversee the activities related to the promotion of indigenous and minority geographical names, as well as to stress the scope of names as cultural heritage. Among the most important topics for the WG are geographical names used by minorities, legislation and policies regarding geographical names as cultural heritage and the promotion of fieldwork and the registration of names.

### **Organization of work**

The work within the WG is organized through meetings in connection with the sessions and on other occasions, preferably as joint meetings with other working groups or divisions or groups of interest.

Because of the wide range of aspects, the work within the working group is preferably organized through different focus groups.

#### Further activities of relevance for the Working Group since 2017

The Swedish handbook *God ortamnssed – Ortnamnsrådets handledning för namnvård* has been translated into English and will be made available online on the website of the Swedish Mapping, Cadastral and Land Registration Authority, Lantmäteriet, <u>www.lantmateriet.se</u>. The handbook is aimed for local authorities in Sweden working with naming and standardization of geographical names, and consists of onomastic information and advices for persons dealing with names and naming. The handbook is based on Swedish legislation, but can serve as an example of good naming practice also for others.

A planned WG meeting at the joint meeting of the Norden Divison and the Dutch-and Germanspeaking Division, held in Brussels, Belgium from 11 to 13 October was cancelled. The participants of the meeting had, however, the opportunity to listen to Professor Kaisa Rautio Helander's talk on Place name policy, standardization and official use of Sámi toponymy, as a well suited example of questions relevant for the Working Group.

# Work plan

- The Working Group will set up focus groups in order to be able to allocate tasks to the different experts within the WG.
- The WG:s website (<u>https://unstats.un.org/unsd/geoinfo/ungegn/wg10.html</u>) contains documents prepared by the WG, as well as examples of good naming practices. The website will also make guidelines available (e.g., regarding commemorative naming). The convenor of the WG invite experts to contribute good examples.
- The chair of UNGEGN, Bill Watt will update the maps made during the initial years of the working group, as long as he is provided data. It would be important to get names used in endangered languages notes on the maps.

- The Working Group will promote and support the national work to consolidate good practice for Geographical Names.
- The Working Group will organize workshops, focusing on topics of special interest for the members of the Working Group, and arrange joint meetings with other Working Groups within the UNGEGN in order to strengthen the work with Geographical Names as Cultural Heritage.
