

Written Statements

Written Statements:

- 2. Allows the extended Bureau and Secretariat to review and prepare summaries, facilitate discussions and find consensus language.
- 3. Must refer to a specific agenda item.
- 4. A submitted written statement from delegation X many be commented on with a written statement from another delegation Y.

- 3. Due to the potential volume of submissions in a condensed period, we encourage written statements to be brief, provided in English if possible, focused on the main discussion items for the Group of Experts, and **submitted to the Secretariat by 23 April.**

What happens during the session

Proposed Modality – see paper <u>General information (un.org</u>)

Body of documents available: summaries, reports and written statements

- 1. Opening of the Session and procedural matters Agenda items 1 and 2
- 2. Substantive matters Agenda items 3 to 15
 - i. Chair <u>opens agenda item and invites introduction of papers for discussion</u>
 - ii. Pre-identified representatives/authors introduce papers for discussion
 - iii. <u>Interventions</u> from delegations who informed the Secretariat in advance of the meeting of their intention to speak under that agenda item.
 - iv. If time permits, additional interventions will be taken from the floor.
 - v. <u>Delivery of the summary of the discussion</u>.
- 3. Review, finalization of decisions and adoption of report on the 2021 session
 - i. The agreed Report will be placed under Silence Procedure immediately following the session.



Protocols - Introduction of Papers and Interventions

Introduction of papers for discussion -

• speakers asked to limit oral introduction to 3 minutes

Interventions from delegations and observers

- Speakers who indicated an intention to take the floor and if time permits others from the floor
 - an interactive manner
- The chair acknowledges and gives the speaker the floor
- Speakers are encouraged to limit interventions/statements to 3 minutes
