# 5. Technical expertise

# (a) Names collection, office treatment, features beyond a single sovereignty and international cooperation

Presentations and discussion will focus on best practices, new approaches, problems faced and possible solutions with regard to achieving national standardization of geographical names. The topic is broad in scope and includes: methods of names collection (field collection, archival sourcing, crowdsourcing, postal surveys, submissions from the general public, etc.); treatment of names in the office (approaches to resolving duplication, name changes, merging of administrative units, commemorative naming, multiple naming and diverse languages and populations, street naming, etc.); legislation, policies and guidelines for names authorities (laws, board structures, principles, programme planning, extent of mandates, relationships of various naming bodies, etc.); names for particular purposes (hydrology, mountain areas, etc.) or standardization requirements of particular user groups (education, emergency operations, different levels of government, etc.). In addition, names of features beyond a single sovereignty are included, as well as items relating to international cooperation on geographical names standardization.

## (b) Geographical names data management

Under the agenda item, the following will be addressed: issues related to the structure and content of toponymic data files and the creation, maintenance and output of databases and gazetteers. The focus may be on technical topics, such as data collection

supported by information technology, data categorization and data modelling and database (web) applications, and more strategic topics, such as the promotion of better integration of geographical names information within national and international spatial data infrastructures and linked data in relation to geographical names standardization. The Working Group on Geographical Names Data Management will provide an overview of the tasks being undertaken to implement strategy 1, on technical expertise – which is focused on the first findings, the challenges faced and the obstacles encountered – and an outlook for the upcoming activities in the period 2025–2027. The Group of Experts is asked to approve and provide guidance on the proposed future work of the Working Group.

#### 6. Relationships, links and connections

This agenda item features the work done to advance strategy 2 of the United Nations Group of Experts on Geographical Names strategic plan and programme of work

2021–2029. The Group of Experts has initiated and maintained, to varying degrees, links with United Nations departments and agencies and non-United Nations scientific and technical organizations and groups, with either formal or informal liaison structures. Liaison with many groups has been active and effective, leading to the provision of advice on the appropriate use of geographical names.

The Group of Experts will also have before it relevant reports prepared by experts from its liaison members, international organizations, academia and other United Nations intergovernmental bodies and entities within the United Nations system. The Group of Experts is invited to discuss the points raised and provide guidance on strengthening existing collaborative activities and creating new partnerships.

In accordance with the recommendations of the Council with respect to collaboration among functional commissions and expert bodies, the Group of Experts continued to strengthen its cooperation with the Committee of Experts on Global Geospatial Information Management. It had designed and proposed to the latter a collaborative project to develop a compendium of institutional arrangements and operational good practices among national mapping and geospatial agencies and national geographical names authorities.

# 8. Culture, heritage and language recognition

The Working Group on Geographical Names as Cultural Heritage was established in response to resolution VIII/1 of the Eighth United Nations Conference on the Standardization of Geographical Names, held in Berlin in 2002. It was formerly known as the Working Group on the Promotion of Indigenous and Minority Group Place Names. The Working Group and its focus groups, aside from the Focus Group on Indigenous Geographical Names, have become inactive, and action items of the Group of Experts programme of work have been suspended. The Bureau of the Group of Experts has created a small incubator group to work on the revitalization of this Working Group, which will present to the Group of Experts the activities undertaken and to seek its guidance on progressing this work item.
