


Figure 1: Proportion of IOs with "Full" and "High" implementation by PRINCIPLES (All and UN Organisations)





Figure 2: Proportion of IOs with "Full" and "High" implementation by PRINCIPLES and good practices (All and UN Organisations)




Figure 4: Proportion of IOs which support a high level endorsement of the PRINCIPLES
